



### **AACPS Office of Service Learning and Mentorships Business/Community Partner Agreement**

The purpose of Service Learning is to provide students with opportunities to improve their academic skills by applying what they learn in school to real world issues. This agreement outlines the responsibilities of the business/community organization.

All approved projects for Anne Arundel County Public School (AACPS) students are evaluated upon the Maryland State Department of Education (MSDE) Seven Best Practices for Service Learning listed below:

1. Address a particular need in the community
2. Connect to curricular objectives
3. Include reflection throughout the service-learning experience
4. Develop student responsibility
5. Establish community partnerships
6. Plan ahead for service-learning
7. Equip students with knowledge and skills needed for civic engagement

The term for the Agreement shall be one school year commencing on \_\_\_\_\_ and concluding on \_\_\_\_\_. This Agreement may be modified only by writing and executed by all parties. This Agreement shall be governed by the laws of the State of Maryland.

#### **THE BUSINESS/COMMUNITY PARTNER WILL:**

1. Provide the student with meaningful service opportunities which, within the confines of organization's needs and time-tables, will enhance and complement the student's academic program.
2. Provide the student with an orientation to the setting upon initiation of each service experience, as appropriate.
3. Adhere to all Federal and State guidelines concerning safety and child labor laws.
4. Adhere to policies and practices which prohibit discrimination on the basis of race, color, national origin, sex, and handicap in recruitment, hiring, assignment to work task, hours of employment, and levels of responsibility.
5. Provide safe and healthful working conditions for the student and hold the School harmless for any injury, illness or damages resulting directly or indirectly from the student's employment activities.
6. Notify AACPS if you are aware that there is a sex offender employed or volunteering at the business/community partner site to afford AACPS the opportunity to terminate the Agreement as to the business/community partner in accordance with the Crim.Proc.Art.Section 11-77.
7. Notify the school of any personnel actions taken which may affect the student's standing regarding service learning with your organization.
8. Abide by all implied and stated terms included in this agreement.
9. Consent for event participants and the organization's logo to be photographed for educational and/or promotional purposes (videos, brochures, articles, social media).
